4.0 STATEMENT OF INTENT AND OBJECTIVES

4.1 Statement of Intent

Mars Canada Inc. is committed to operating in an environmentally responsible manner that meets all federal and provincial regulations. PM_{10} is not used at the Facility. It is created when it becomes air borne during production processes, as well as material storage and handling. It is also created from fuel combustion. No technically and economically feasible reduction options to reduce the creation of PM_{10} were identified.

Therefore, the Mars Canada Inc. Bolton Site does not intend to reduce the creation of PM_{10} at this time.

4.2 Objectives

The objective was to identify feasible reduction options. The Mars Canada Inc. Bolton Site was unable to identify any reduction options which were both technically and economically feasible.

5.0 DESCRIPTION OF SUBSTANCE

PM_{10} is not used at the Facility. It is created when it becomes air borne during production processes, as well as material storage and handling. It is also created from fuel combustion.

6.0 RATIONALE FOR NOT IMPLEMENTING REDUCTION OPTIONS

The Mars Canada Inc. Bolton Site was unable to identify any reduction options which were both technically and economically feasible, therefore no reduction options will be implemented.


